

**THE MUSSAR INSTITUTE**  
**License Agreement for**  
**JEWISH VALUES FOR EVERYDAY LIVING**  
**MUSSAR FOR CHILDREN CURRICULUM**

This License Agreement (“Agreement”) confirms the terms and conditions under which The Mussar Institute (“TMI”) agrees to license the Mussar for Children Curriculum (the “Curriculum”) to

---

(the "School") as of the date signed by the School below (the “Effective Date”).

1. TMI hereby grants to the School the non-exclusive right and license to use the Curriculum and the related lesson plans, images, facilitator guides, worksheets and training material (collectively, the “Curriculum Materials”) for the benefit of the faculty, parents and students of the School as of the Effective Date, in perpetuity, unless this Agreement is terminated (the “Term”).
2. The School shall pay to TMI the amount of \$399 for the full curriculum or \$199 for the Aleph, Bet or Gimel packets, as appropriate.
3. Upon receipt of this signed Agreement, TMI will give the School access to the full Curriculum and materials on its course-site.
4. The School shall be entitled to implement the Curriculum during the Term.
5. Curriculum Materials may not, during or after the Term of this Agreement, be modified by, nor shared with, disseminated to, anyone outside the School, nor posted to the Internet, distributed or published in any form, at any time, including if this Agreement is terminated.
6. The School recognizes that TMI owns the content of the Curriculum and Curriculum Materials, and that the School has and will have no rights in the Curriculum and Curriculum Materials other than those specifically granted in this Agreement, and only for so long as this Agreement shall be in effect. The Curriculum and Curriculum Materials are the exclusive property of TMI, which reserves all rights of use, distribution and reproduction worldwide.

7. The School may terminate this Agreement if TMI fails for thirty days after notice from the School to furnish Curriculum Materials. TMI may terminate this Agreement if the School fails for thirty days after notice from TMI to observe any of the terms and conditions of this Agreement, including specifically the terms of paragraph 6 above. Promptly upon any termination, the School shall return all Curriculum Materials to TMI.

8. The School shall be entitled to any corrections to the Curriculum at no additional cost.


9. This Agreement may not be assigned for payment or performance by the School and shall be governed and construed under the laws applicable to matters occurring entirely within the State of New York.
